



These instructions are for MedTech v17.1 or above, for exporting the MHN (PHO) Clinical Event Export

- Go to **(Utilities| LinkTech | PHO Clinical Event)**
- Ensure the date range is from Start of Last Quarter to End of Last Quarter (last 3 months)
- Enter your practice identifier if not pre populated (you can get that by checking the practice identifier under Utilities LinkTech | PHO Export)
- Tick **Generate Summary Report**
- Tick **Export Service Utilisation Information**
- Tick **Include Cervical (CX) and Mammography (MAM) screening**
- Tick **Extend the date range for IMM, CX and MAM to cover audit periods**
- Tick **Export Clinical Performance Information**

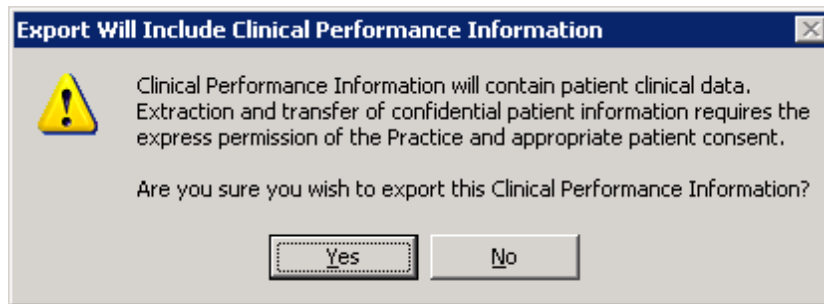

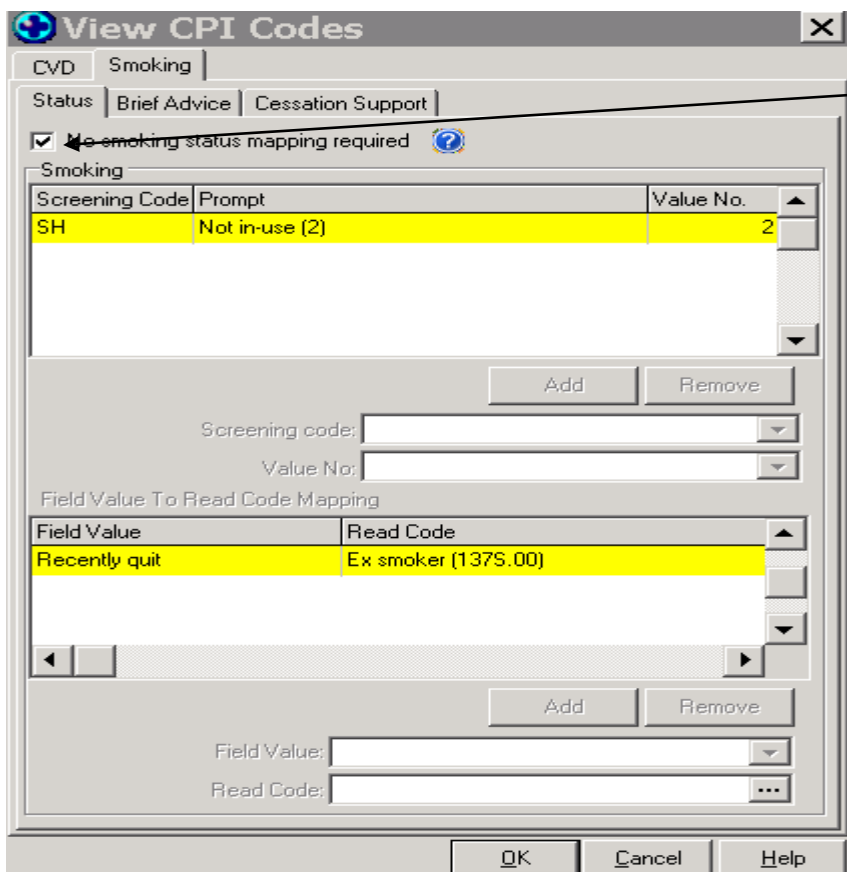
CVRA screening codes

If you have not set up your CVRA screening codes – please contact your Practice Support. **It is important that you match the codes with those you are using.**

Smoking Codes

Click on the Smoking tab at the top of the screen, the Smoking Indicator mapping screens will be displayed.

If you are using **Read Codes** to classify smokers, you do not need to do anything. The **No smoking status mapping required** defaults to being ticked. If you are using screening **codes** and these have not being mapped contact your Practice Liaison.



If you have only ever used **read codes** for recording patients smoking status, the new tick box can be selected.

If you **have** in the past recorded patients smoking status using **screening code/template** contact your Practice Support to help set up the mapping if this has not been done previously

Submitting data to MHN

- Select **HealthLink mailbox** and enter **pinnacle** as the HealthLink mailbox
- Tick **Compress (zip) this export**
- Click **OK** to send
